## <u>Theme:</u>

Increase in the share capital of the subsidiary Odlewnia Rafamet Sp. z o.o. in Kuźnia Raciborska.

## <u>Message:</u>

The Management Board of Fabryka Obrabiarek RAFAMET S.A. announces that today the Extraordinary Shareholders' Meeting of Odlewnia Rafamet Sp. z o.o. adopted a resolution on increasing the share capital of Odlewnia Rafamet Sp. z o.o. by PLN 1.000.000, i.e. to the amount of PLN 33.000.000 by establishing 2.000 new shares with a nominal value of PLN 500 each. The newly-established shares in the increased share capital of the subsidiary were intended to be taken up by the existing shareholder, Fabryka Obrabiarek RAFAMET S.A. The increased capital will be fully covered in cash.

The decision to increase the share capital of Odlewnia Rafamet Sp. z o. o. was made in performance of § 1 section 4 of Resolution no. 13/l/23 of the Extraordinary General Meeting of RAFAMET S.A. of 15 February 2023. on the increase of the Company's share capital through the issue of ordinary bearer shares of series G and ordinary registered shares of series H in the mode of private subscription, with exclusion of the preemptive right vested in existing shareholders in full, and on the dematerialisation of series G shares and series H shares, and on the application for admission and introduction of series G shares to trading on a regulated market, as well as on the amendment of the Company's Articles of Association (Current Report no. 8/2023 of 15.02.2023). In accordance with the realisation of the issue objective of the Issuer's share capital increase, the share capital of the subsidiary was increased by PLN 16.000.000, within the deadlines resulting from the timetable established by the Management Board of Odlewnia Rafamet Sp. z o. o. for the implementation of the research and development project entitled: "Development of an innovative technology for the production of large-size ductile iron castings with special properties in Full Mould technology, dedicated to the production of stamping tools in the automotive sector".

In addition, the Company learnt that on 13.12.2023 the District Court in Gliwice, X Commercial Division of the National Court Register, registered an increase in the share capital of Odlewnia Rafamet Sp. z o.o. made pursuant to the resolution of the Extraordinary Meeting of Shareholders of Odlewnia Rafamet Sp. z o.o. by PLN 500.000, through the establishment of 1.000 new shares with a nominal value of PLN 500 each (Current report no. 53/2023 of 30.11.2023).
